During the month of August 2023, the school held a "Meet and Greet" with families and provided school supplies to families that requested school supplies. In addition, the school provided uniform pants to a student whose parent informed us of a need of assistance.
Child Care	The school provides childcare during parent meetings and workshops. School staff reads stories and plan arts and craft activities so parents can attend informational meetings. Our school also offers a principal operated after school care program.
